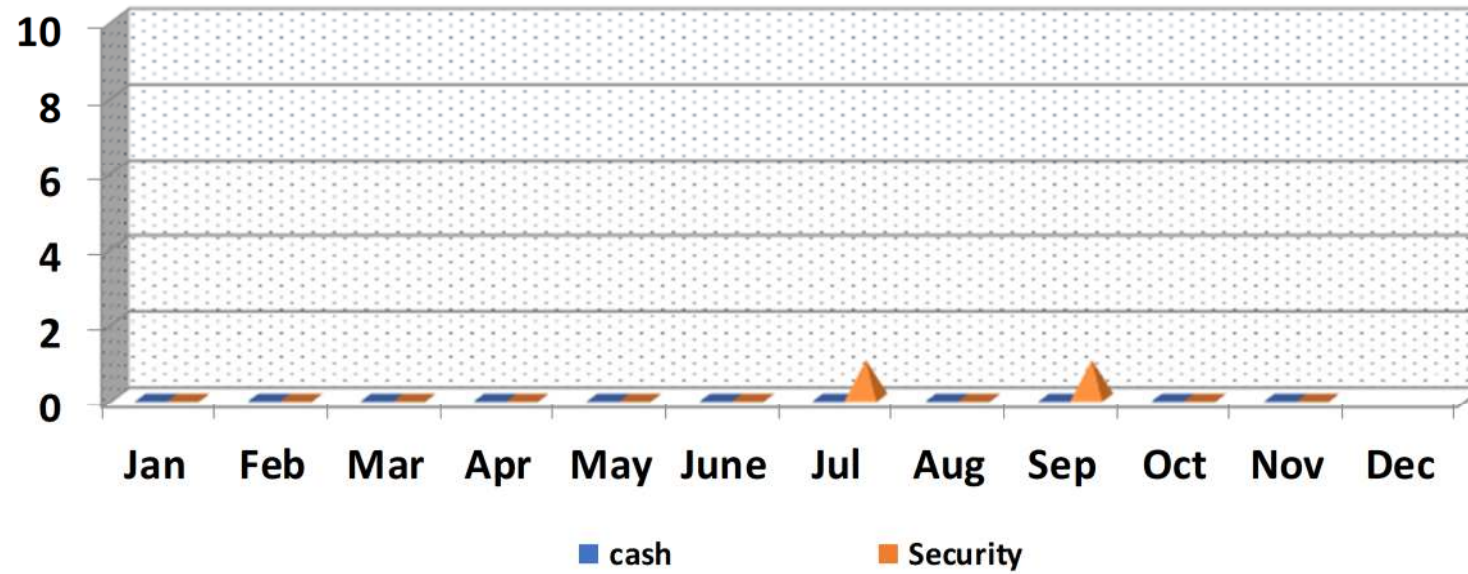
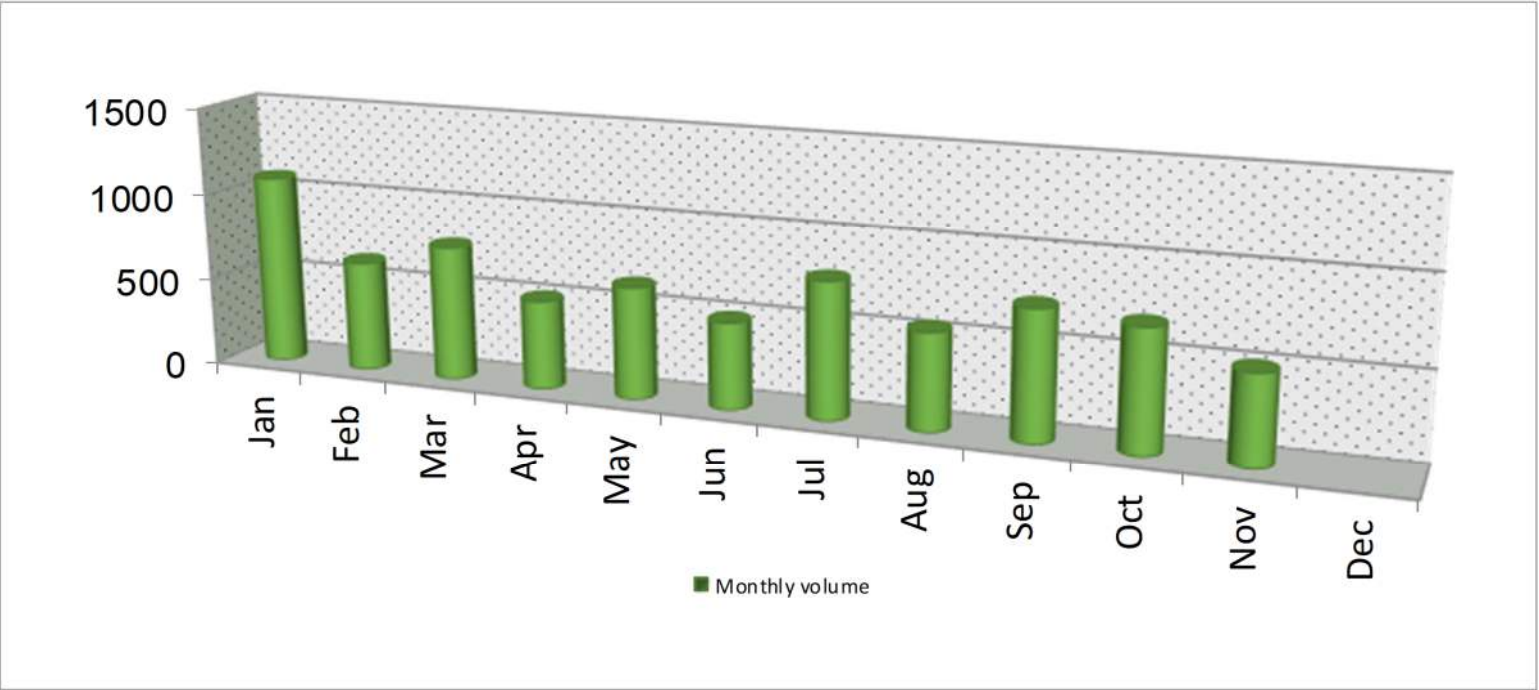

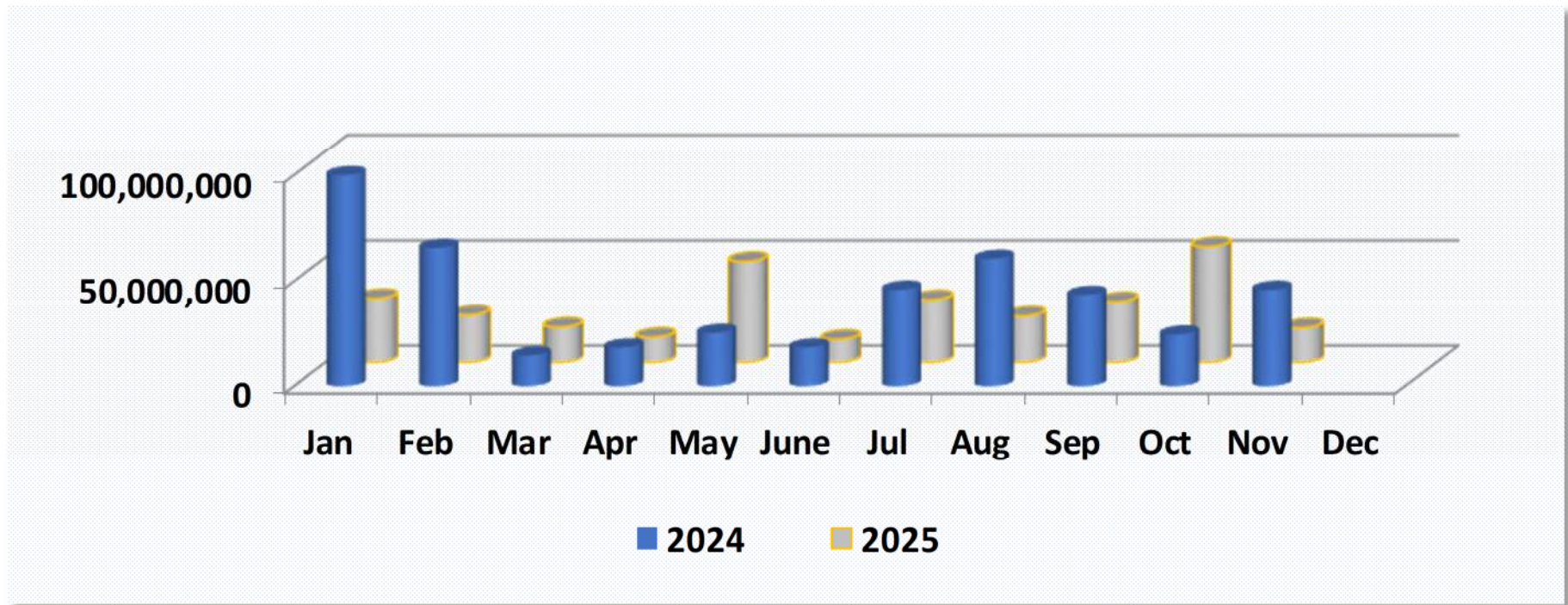

2025 Monthly volume of transactions settled at Midclear



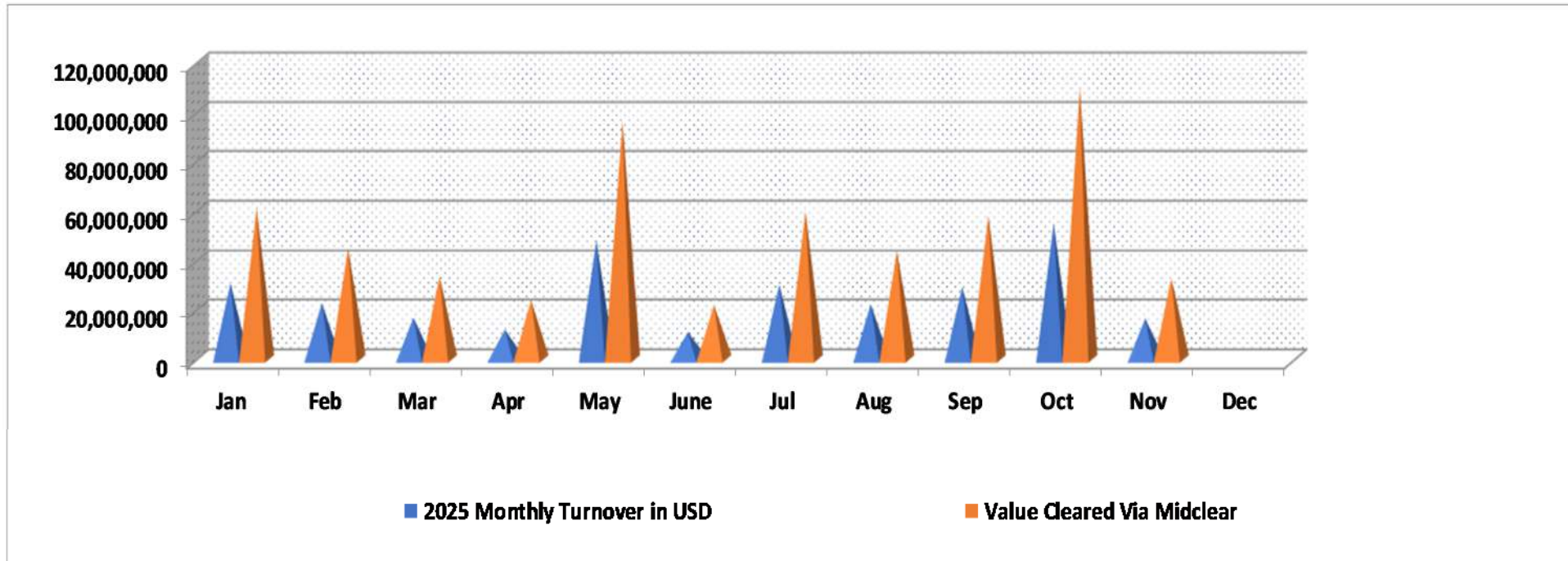

2025 & 2024 BSE Monthly Value of traded Shares



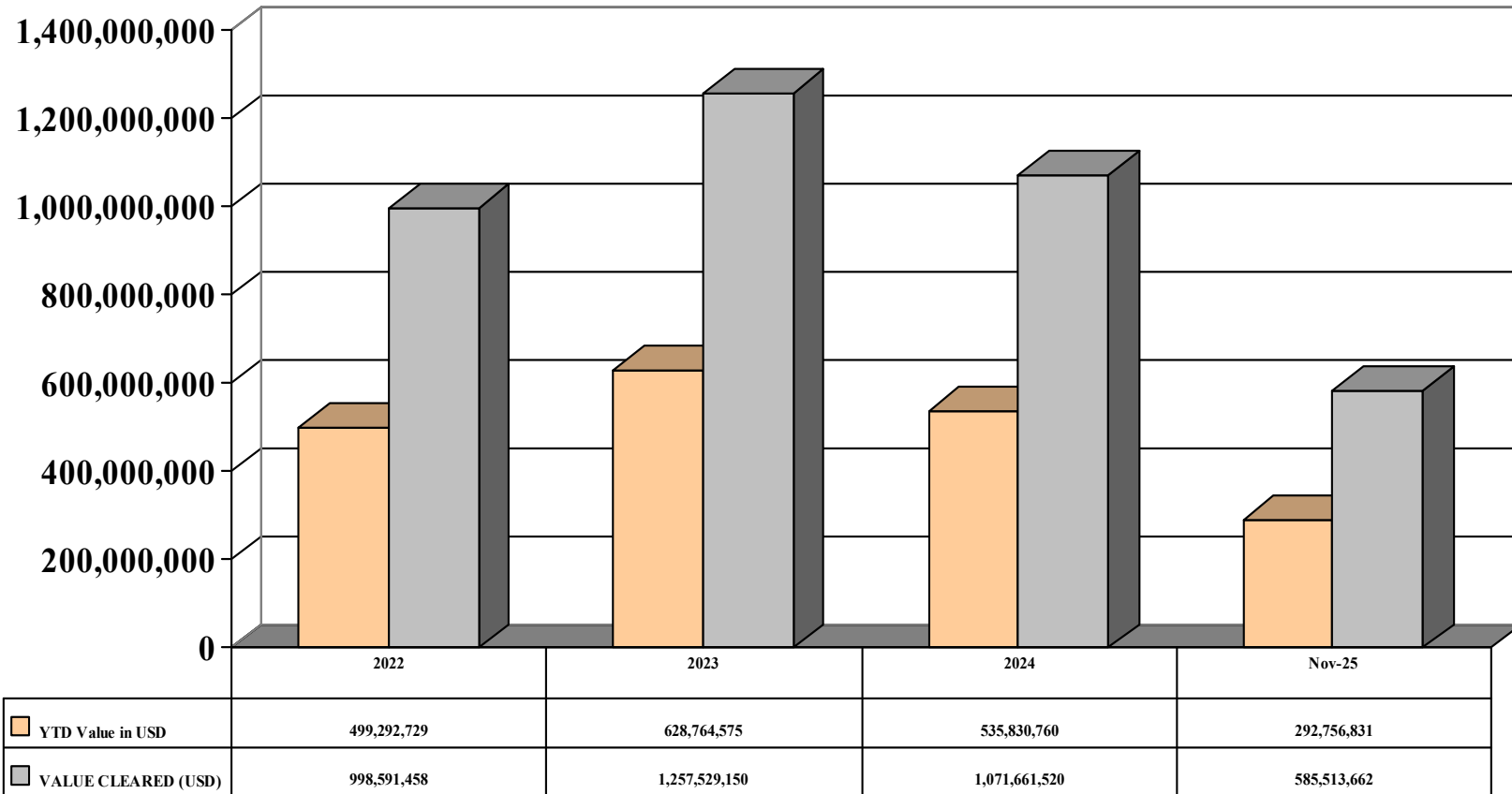

2025 Monthly BSE turnover and Value Cleared at Midclear

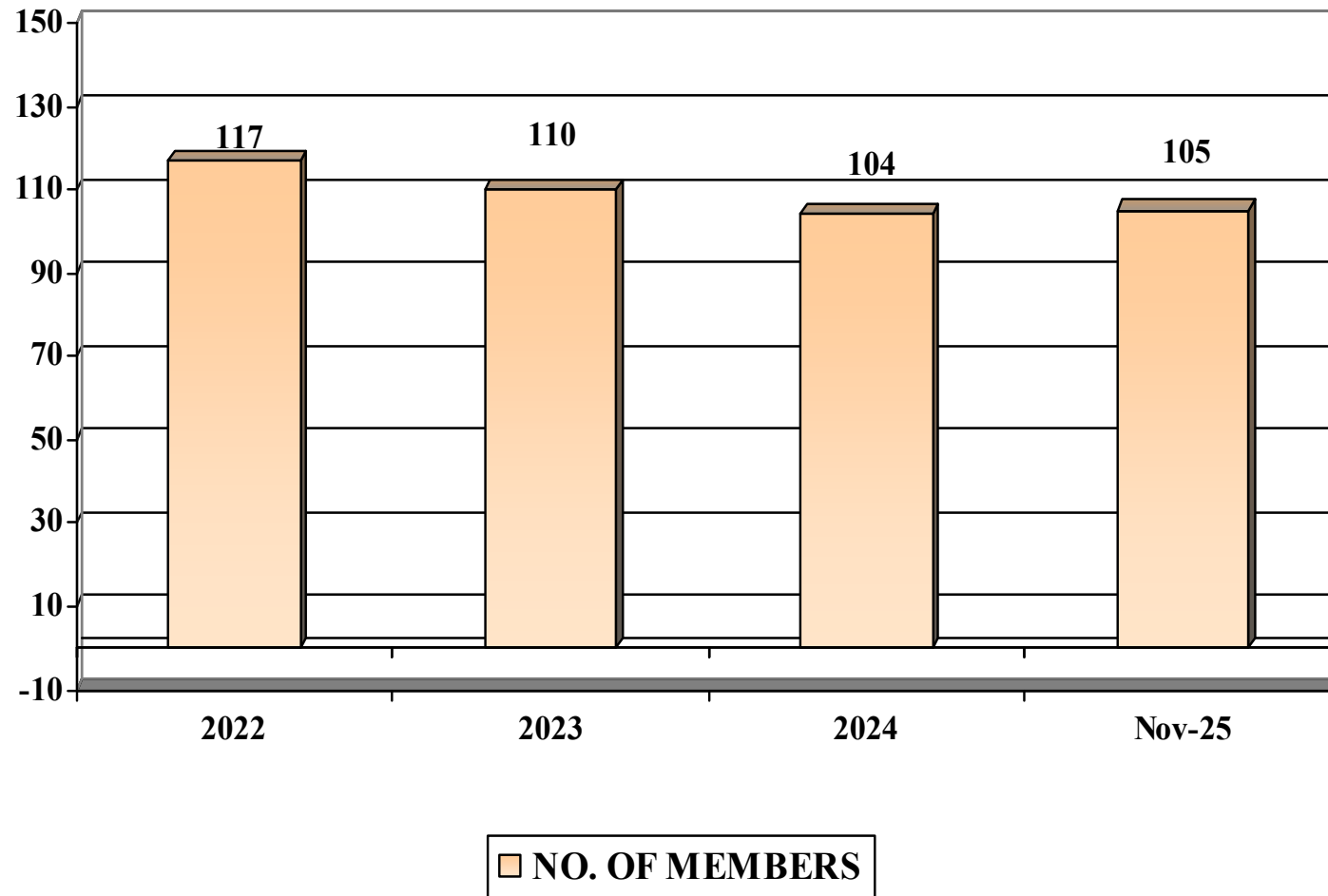

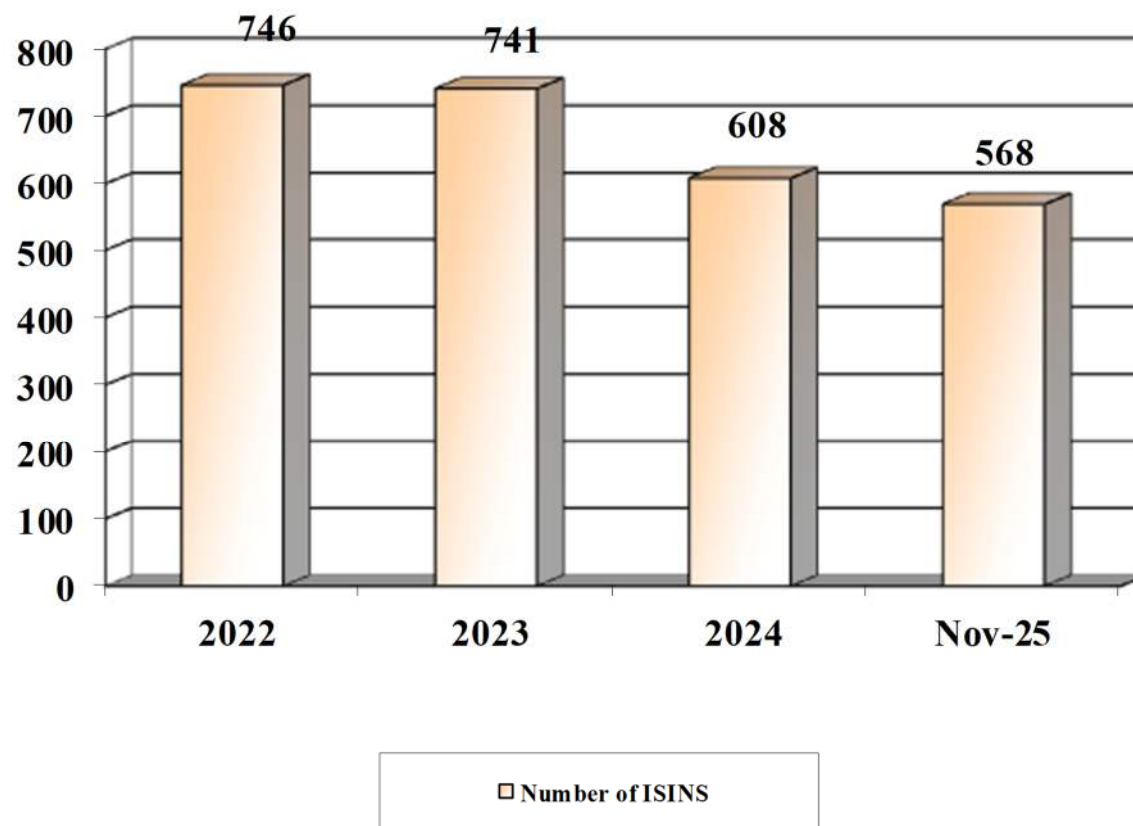
YTD VALUE OF SECURITIES TRADED AND CLEARED THROUGH MIDCLEAR



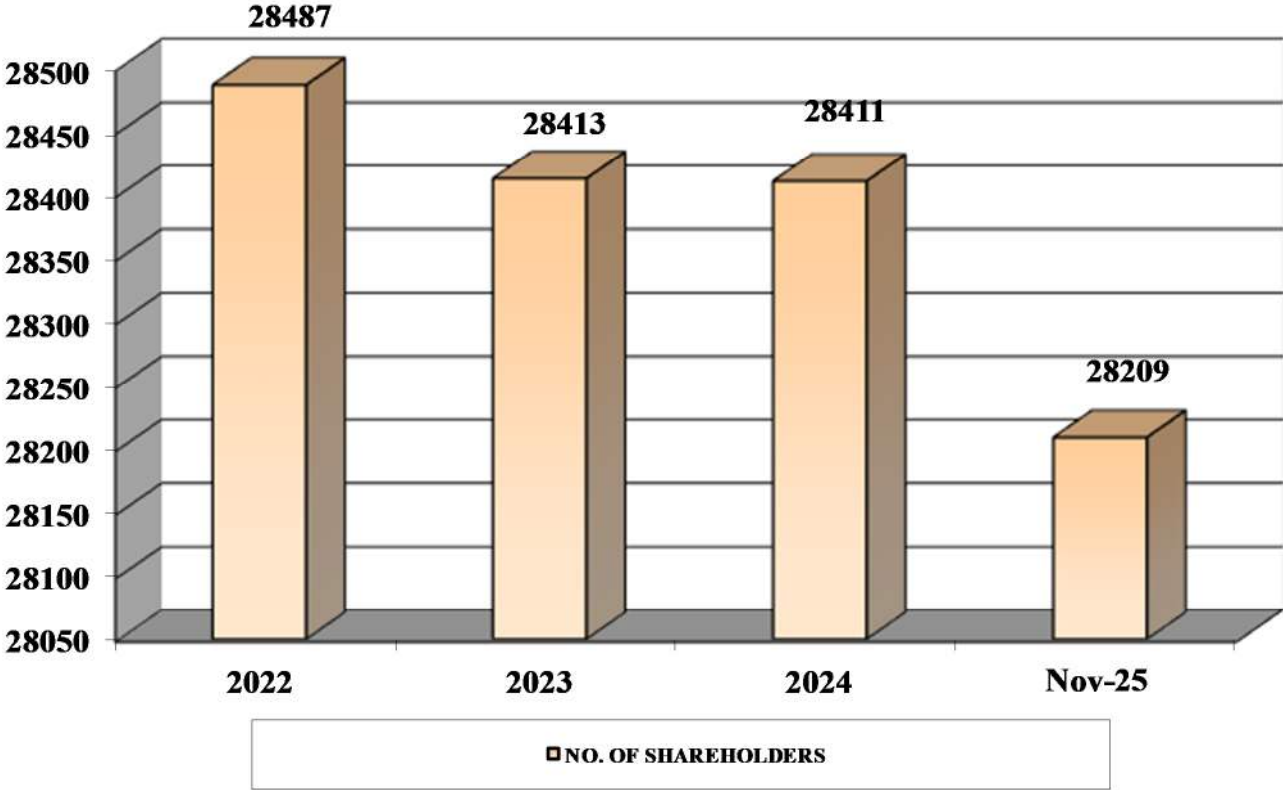

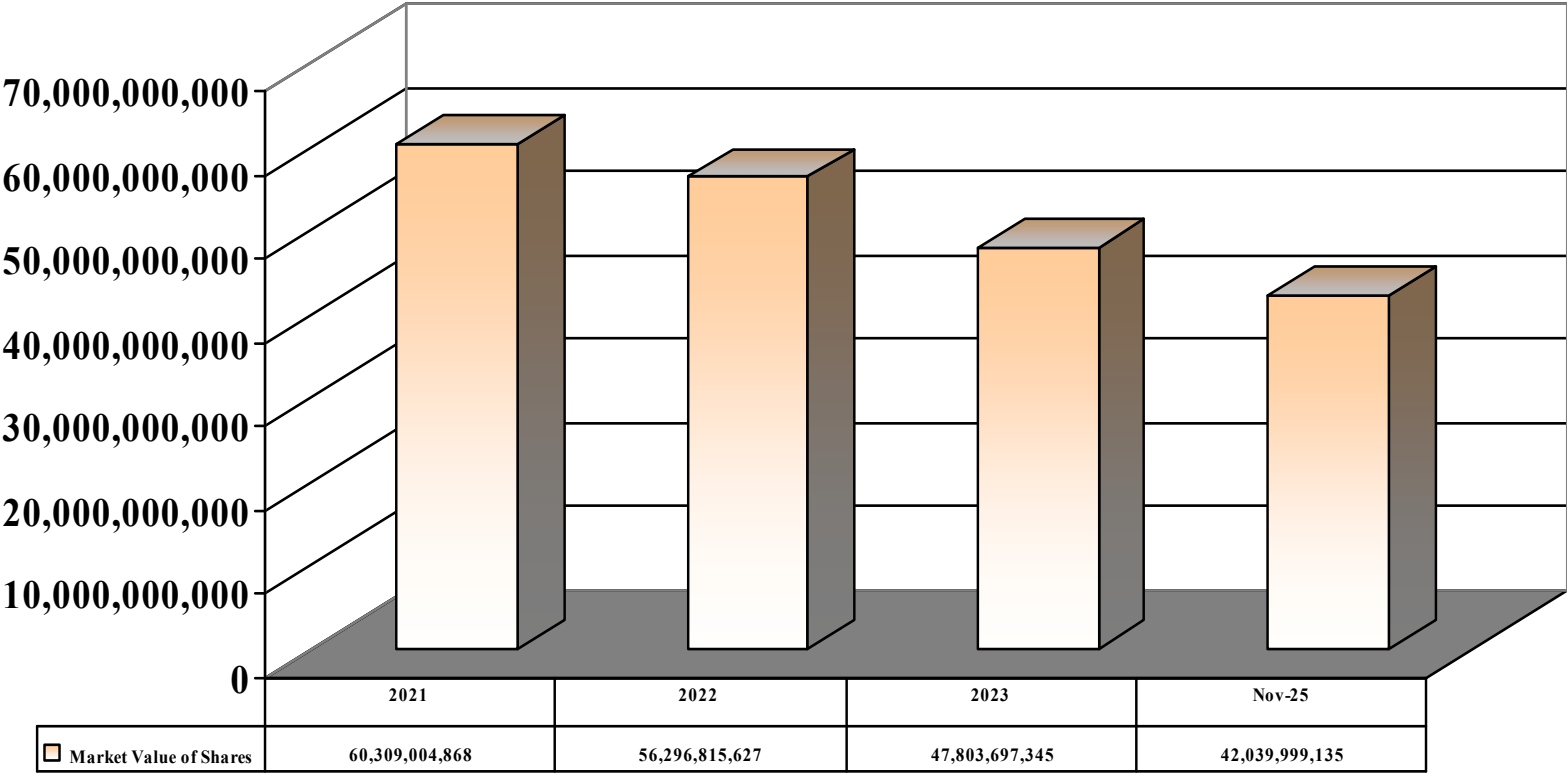
